QUESTION & ANSWER NEIGHBORHOOD ASSISTANCE PROGRAM

NAP tax credits provide funds to nonprofit organizations to complete specific projects and enable donors to reduce their tax liability.

Our Tier 1 Members can claim the NAP credits when they file their Missouri tax return. They can also claim the donation on their federal income taxes, and receive a related deduction on their states tax return. There is no minimum or maximum donation limit.

The following groups are eligible for Tier 1 Membership and to donate:

- Individual partner in partnership or shareholder in S-corporation
- Individuals who pay Missouri state income tax AND
 - Own a sole proprietorship
 - Operate a farm
 - Have rental property
 - Receive royalty/honorarium income
- Corporations (filing MO Form 1120)
- Small business corporations (filing MO Form 1120S)
- Banks and financial institutions (filing MO Financial Tax Return)
- Partnerships (filing MO Form 1065)
- Insurance companies (filing MO Insurance Tax Return with the MO Department of Insurance)
- Limited Liability Companies (filing MO Form 1120, 1120S, 1065)
